### **European Monetary Institute 1994 – 1998**

**Scope and content**

The European Monetary Institute (EMI) fonds mainly consists of documents relating to meetings, working papers, correspondence and reports of the EMI and the expert groups staffed by EMI and central bank representatives (and sometimes others). It covers all topics of relevance for the preparation of monetary union in 1998, such as statistics, monetary policy and payment systems and their harmonisation in view of the introduction of the single currency and the establishment of the European System of Central Banks (ESCB).

It also includes documents related to interactions with European and international institutions, private-sector banks and fora as well as material of other (related) organisations and fora, such as the Monetary Committee in Brussels.

**Dates**

The EMI was active between 1 January 1994 and 31 May 1998. However, the fonds contains documents dating from 1991 to 1999.

**Extent of the fonds**

The overall size of this fonds is approximately 85 linear metres.

**Administrative history**

In 1992 the Treaty on European Union, also known as the Maastricht Treaty, laid out a road map to a common currency and central bank for the EU. As part of this, the EMI was established in January 1994 as a crucial step towards establishing the European Central Bank (ECB). The establishment of the EMI also meant the dissolution of both the Committee of Governors of the Central Banks of the Member States of the European Economic Community (EEC) and the European Monetary Cooperation Fund (EMCF). However, the newly established EMI was not a break with the past and continued many of the activities of the Committee of Governors and the EMCF. For instance, working groups and task forces seamlessly continued their activities, and the EMI took over the operational and reporting tasks of the EMCF, with the Bank for International Settlements (BIS) continuing to act as Agent until May 1995.

Unlike the Committee of Governors which preceded it, the EMI had its own legal personality and expanded rapidly, both as an organisation and in terms of staff numbers. The EMI's first President, Alexandre Lamfalussy,

was succeeded in July 1997 by Willem Frederik Duisenberg, who went on to become the first President of the ECB in 1998. The President of the EMI chaired the EMI Council, which also included the Vice-President of the EMI and the governors of the central banks of EU Member States.

Over the next four and a half years, the EMI quickly established its organisational structure. Major work was done in parallel by sub-committees, working groups and underlying task forces of the central banks and the EMI.

The EMI's focus was on establishing the ESCB, including the ECB, and paving the way for the new common currency. Among other things, it aimed to:

- better coordinate monetary policy in the EU;
- enforce financial stability;
- improve (cross-border) payment systems in the EU;
- develop a regulatory, organisational and logistical framework;
- develop a common monetary policy strategy for the euro;
- prepare a single money market.

During the first eleven months of its existence, the EMI was still hosted at the BIS in Basel, while intensive preparations were underway, including at the Deutsche Bundesbank, to establish a new home for the EMI in Frankfurt am Main. In November 1994 the EMI moved into the Eurotower (previously known as the BfG-Hochhaus) in central Frankfurt.

The EMI conducted its business in an environment dominated by technocratic procedures and expectations and by political objectives.

### **Custodial history**

The documents of the EMI were stored at the BIS in Basel during the first eleven months of its existence. With the move to Frankfurt am Main in November 1994, the already existing documentation was transferred to the new seat and formed, together with the documentation of the Committee of Governors and the EMCF, the nucleus of the newly created EMI Archives. The EMI Archives then mainly served as the central registry for the daily document production of the EMI.

### **Appraisal and destruction**

The arrangement and description of the EMI files required a certain amount of selection and disposal. This procedure was aimed, for instance, at the destruction of duplicates, ephemeral/administrative documents, copies of academic papers and of external material without links to the EMI, printouts or photocopies of legislative texts, and reference material of business areas or individual staff members without additional value for the institutional memory.

### **System of arrangement**

A filing plan was quickly established to cover daily document creation and administration by the EMI Archives as the centralised registry. However, substantial documentation created by the business areas for their operational needs remained outside the EMI Archives. In certain areas, the local documentation was more comprehensive than that kept centrally. Subsequently, a new system of arrangement, as shown below, was introduced, covering both parts of the EMI documentation and reflecting the former functions and activities of the EMI.

### **Conditions governing access**

EMI documents are freely accessible, except those relating to the commercial interests of natural and legal persons, including intellectual property, or those whose confidentiality still needs to be protected in the public interest. Furthermore, documents containing sensitive personal data or data relating to the privacy and integrity of individuals are not made available until 100 years after their creation date unless additional safeguards can be applied.

These access conditions are laid down in Articles 4, 5(1), 8(2) and 9 of Decision (EU) 2023/1610 of the European Central Bank of 28 July 2023 establishing the historical archives of the European Central Bank and amending Decision ECB/2004/2 (ECB/2023/17).

### **Conditions governing reproduction**

Released EMI documents can be freely reproduced for personal, research or academic use, while for any commercial use the prior authorisation of the ECB is required. Users remain responsible for observing the copyright of third parties.

These access conditions are laid down in Article 10 of Decision ECB/2023/17.

### **Languages**

The main languages used for documents created or held by the EMI were English, French and German. Since the 1970s there has been a growing trend towards English becoming the dominant language in an international environment, particularly in the financial sector. During the EMI period, English was already the dominant language in the financial sector and was the working language of EMI staff. However, the EMI fonds covers a variety of languages beyond English, French and German, including some non-EU languages. The EMI Council continued to write agendas and minutes in French and German as well as English, and many major reports of sub-committees and working groups were translated into German and then into English.

The EMI language regime remained a sensitive topic, especially in view of public perception. President Lamfalussy and then President Duisenberg regularly spoke in languages other than English, for instance at

conferences, and the EMI responded to public requests for information and occasionally interacted with national institutions in the respective national languages.

**Existence and location of copies and originals**

The EMI was an essential part of central bank and EU cooperation in the 1990s. This means that related documentation can also be found in many other central bank, national and EU archives, provided it was delivered to those archives by the originators.
