- 2. **Description of the fields covered:** The ECB wishes to contract with a specialist service provider who can provide predominantly expatriate staff joining the ECB at all levels with a relocation service upon their arrival in D-Frankfurt. The service should include:

 - a personalized service to enable individual members of staff to find and move into appropriate accommodation and settle in D-Frankfurt (i.e. excluding removal services).
