## Recent resolutions on CRs since last meeting

The CRG chairperson, Karen Birkel, welcomed the participants and introduced the meeting held remotely. The CRG members proposed to change the background document T2-0129-URD under Change requests raised in other TARGET Services to be an oral update. The CRG approved the agenda of the meeting on 4 July 2023 and no additional items were proposed.

- > The following CRs have been already authorised by the T2S Steering level / under detailed assessment:
  - T2S-0784-SYS "Update in the Credit Memorandum Balance configuration to allow leveraging on the CCBM model". The CRG members took note that the PMG requested the detailed assessment of CR-0784, ranked as number 5 out of 16, in view of R2024.JUN on 6 June 2023.
  - T2S-0794-URD "T2S settlement day processes for DKK". The CRG members acknowledged that the MIB authorised CR-0794, ranked as number 15 out of 16, on 21 June 2023.
  - T2S-0796-SYS "Secured Groups should have name and description attributes". The CRG members took note that the PMG requested the detailed assessment of CR-0796, ranked number 12 out of 16, in view of R2024.JUN on 6 June 2023.
  - T2S-0797-SYS "T2S should support cross-border settlement via alternative Security CSD Links". The CRG members took note that the PMG requested the detailed assessment of CR-0797, ranked number 3 out of 16, in view of R2024.JUN on 6 June 2023.
  - T2S-0800-URD "Harmonisation of floor/ceiling notifications with T2". The CRG members took note that the PMG requested the detailed assessment of CR-0800, ranked number 11 out of 16, in view of R2024.JUN on 6 June 2023.
  - T2S-0804-SYS "T2S Billing amendments stemming from audit report". The CRG members acknowledged that the MIB authorised CR-0804, ranked number 10 out of 16, on 21 June 2023.
  - T2S-0805-SYS "ESMIG Portal access rights redesign". The CRG members took note that the PMG requested the detailed assessment of CR-0805, ranked number 9 out of 16, in view of R2023.NOV on 6 June 2023.

The CRG agreed that the proposed release scoping adequately reflected the CRG implementation priorities.

  - T2S-ICN-0047 PBI-227245 NCB user cannot amend field "Statement Means of Payment" in NCB invoice configuration. The CRG took note of the T2S impact on 19 June 2023.
  - T2S-ICN-0053 PBI-227488 [PROD] change of default-Flag in user-dn-link to 'yes' is shown as 'no' while approval. The CRG took note of the T2S impact on 19 June 2023.
- > The following SDD-PBR have been approved by the CRG:
  - SDD-PBR-0096 on PBI-227028 Unknown error DSU1923 triggered for update security name. The CRG approved the note on 23 June 2023.
  - SDD-PBR-0097 on PBI-227459 RBOK Value not understood by GUI. The CRG approved the note on 21 June 2023.
  - SDD-PBR-0098 on PBI-227593 Procedure for Liquidity Transfers arriving after cut-off. The CRG approved the note on 26 June 2023.
  - SDD-PBR-0099 on PBI-227933 Uniqueness of Party Links in Report Configuration for T2S. The CRG approved the note on 23 June 2023.
  - SDD-PBR-0100 on PBI-227672 CFI-Liquidity Indicator. The CRG approved the note on 23 June 2023.

The CRG members took note that during the CSG meeting on June 2023 meeting, it was agreed to:

- Delegate to the CRG the authorisation and approval of editorial change request. The T2S Steering Level would only be informed afterwards, and the approval timeline would be shortened.
- Raise a change request to enhance the NRO and make sure that the signing user is the same as the logged in user. It was also acknowledged that a fast-track approach should be followed.

The CRG took note that the members emails have been collected via written procedure to set-up the closed community in MyStandards so that they can receive the non-binding XSDs as of R2023.NOV. It was clarified that the delivery of the XSDs for R2023.NOV was not provided because the only message affected was the camt.077 'Billing report' and there was a discussion running in the PMG to assess the de-scoping of CR-0803-SYS (Upgrade of Billing Report message (camt.077)) from the scope of R2023.NOV. It was agreed that once this decision was made at PMG level, the CRG secretariat would inform the CRG accordingly.

#### Outcome

#### T2S-0806-URD Removal of T2S functionality for the identification of penalties related to a CCP

The CRG members took note of the newly raised Change Request CR-0806 by the CSDR Task Force that foresaw to decommission the functionality to report when a CCP was a participant in a transaction for which there was a penalty computed.

It was acknowledged that CR-0806 was raised in the context of the amendment of the Article 19 of Commission Delegated Regulation (EU) 2018/1229 "Penalty mechanism where the participant is a CCP" and that the expected entry into force was July 2024. The change request envisaged a phased approach, with a short-term solution first to be implemented that did not require software change and a long term one with the decommission of the functionality. 4CB informed that the short-term solution that foresaw to empty the CCP participants list could fully meet the requirement to still report the flag for the penalties recalculated after the date of entry into force. Nevertheless, 4CB still had to confirm whether the recalculation of cash penalties stemming from reallocation would need to be triggered before the table is emptied (by the last day of the month) to support the "dual logic" and flag the CCP in the report. The CRG enquired how important it was to support the "dual logic" to be able to correctly flag recalculations done between the end of the month and the end of appeal period. Especially, it was highlighted that this requirement should not jeopardise the implementation of the change request in case the workaround option would not work. In this respect, 4CB as part of their analysis would aim to provide some statistics on how many cases of this nature there were.

It was acknowledged that the OMG would be responsible for organising the way forward on the workaround including its testing once feasibility was confirmed by 4CB.

### Follow-up actions:

- 4CB to confirm the feasibility of the workaround solution to stop reporting the CCPs flag in the penalty reports for CR-0806 and in particular for the recalculation of penalties made after emptying the table at the end of the month and until the end of the appeal period of the following month, except those stemming from reallocations. [6 September 2023]
- 4CB to provide statistics related to the number of recalculation of penalties made after the end of a calendar month and until the end of the appeal period of the following, including a break-down of the number of reallocations during this period [6 September 2023]
- ECB Team to coordinate with OMG Secretariat for organising the way forward on the workaround including its testing once feasibility is confirmed by 4CB. [6 September 2023]

### Presentation on CR-0807: Scenarios to report Partial Differ

The CRG took note of the updated wording of CR-0807, covering the changes compared to the previous version shared for the May meeting and stating that the unsettled reason coded 'Partial Differ' would only be provided once the transaction was eligible for settlement.

The CRG took note of a presentation on the topic with practical scenarios where the new reason code would be reported. The CRG approved the changes proposed to the wording of CR-0807 and agreed to request the preliminary assessment.

#### Outcome

### T2S-0809-SYS Alignment of T2S Messages with ISO Maintenance Release 2020 – 2024)

The CRG took note of the wording of CR-809 with the purpose to align T2S Messages with the ISO MR2020-2024. It was acknowledged that this deliverable was provided only the day before of the meeting. Hence, the CRG agreed to launch a written procedure to review it and assess the recommendation for the Steering Level authorisation. The CRG took note that the "Standard Compliance" change request did not need a preliminary assessment since the business need was already confirmed in the context of the ISO unfreeze strategy.

4CB informed that to meet the planning foreseen in the ISO unfreeze strategy, CR-0809 would need to be authorised by end of September 2023, so that the detailed assessment could be started thereafter.

#### Follow-up actions:

The ECB team to launch a written procedure to approve the CR parameters and assess to recommend CR-0809 for Steering Level authorisation. [30 July 2023]

The CRG took note of an oral update related to a new change request T2-0129-URD 'CRDM admin users access rights scope limitation' that was about to be raised by the T2 community and that foresaw to reduce the scope of a user to view and delete Certificates Distinguished Names in CRDM.

The CRG had concerns that this CR might have significant impacts on user management across different entities, namely that certain setup scenarios that worked at that point in time, could no longer be supported. And that more detail on the scope of this CR was urgently needed to assess whether the concerns were justified. Considering that there was no background documentation, the CRG requested to be provided with the change

request as soon as it was finished so that they could review it and a new discussion could be held.

#### Follow-up actions:

The ECB team to urgently launch a written procedure to review T2-0129 'CRDM admin users access rights scope limitation' as soon it was available. [31 August 2023]
