

The T2S community testing activities are performed on the Community testing environment (MIG2), to which TARGET2 CUST is connected. This testing phase is approaching completion, in line with the testing schedule (4 August 2017). From that moment onwards, testing activities by the T2S communities will take place on the Pre-production environment (Utest). As a consequence TARGET2 CUST needs to be connected permanently to Utest. This switch will occur on the 24 and 25 July 2017 according to the following schedule:

This may require that static data are adjusted when TARGET2 is connected to Utest. Participants that need to adjust their static data must contact their respective Central Banks.
